CEC has no eligibility requirements and also can serve clients with Medicaid. The Counseling and Education Center uses on-going assessments and numerous systems of measurement to assure effective treatment of each client. "Feedback Informed Treatment" and "My Outcomes" data system provides real-time effectiveness measurement. The organization had 16 volunteers representing 189.25 hours of service.

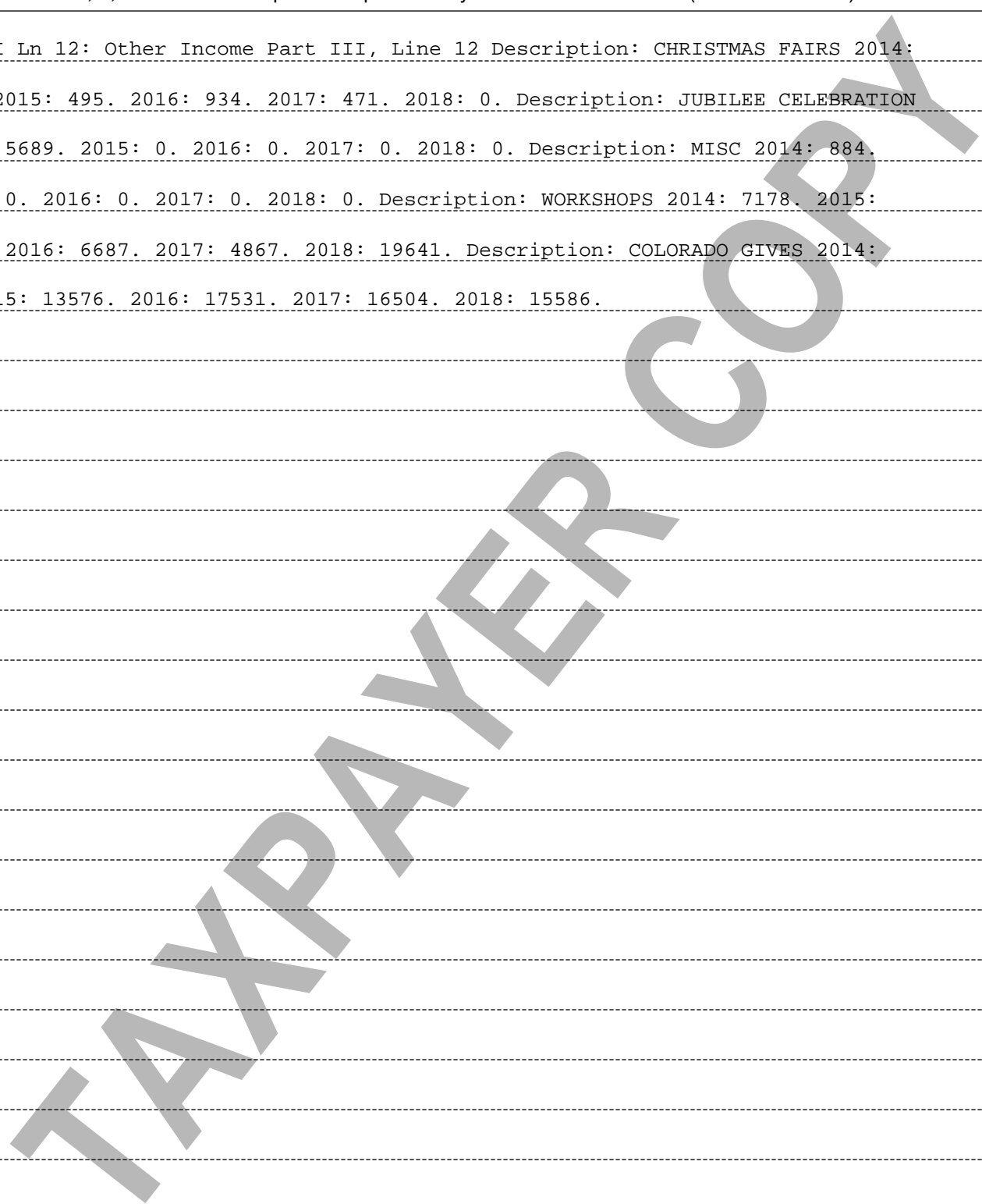
