Acquisition of private lands in current and potential wilderness areas from willing sellers and transfer of those lands to public ownership so that all generations of Americans will enjoy an enduring source of wilderness. During the fiscal year ended June 30, 2016, TWLT purchased 6 properties throughout California, Colorado, New Mexico and Nevada for a total of 4,712 acres. TWLT transferred 5 properties, a total of 307 acres located in Arizona, California, Colorado, Oregon, and Washington. The Wilderness Land Trust is actively working on the preservation of 33 properties in 9 western states, including Alaska, Arizona, California, Colorado, Idaho, Nevada, New Mexico, Oregon and Washington.

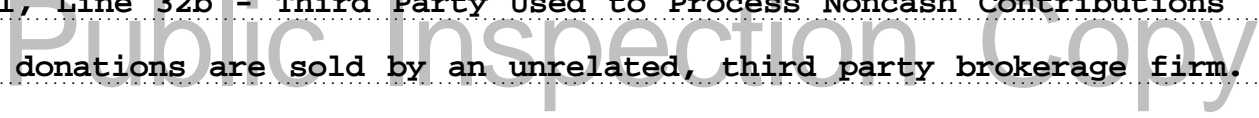
