During the year, the Organization began the process of reassessing the needs of the senior community and the services that have been offered to meet those needs. As of August 2017, the Organization no longer provides employment services to the senior community as part of its normal program services. Providing employment services required an enormous amount of the Organization's resources, and the impact to the senior community at large was difficult to measure.

Since then, the Organization's full resources have been available to provide assistance to seniors by offering them food, counseling and other assistance.
