Social Services -
The Salvation Army provides a wide range of traditional social services and emergency assistance programs. The programs vary by community and include meal assistance, emergency shelter, transitional housing, medication payment assistance, job training, rent and utility assistance, substance abuse rehabilitation, youth programs, senior housing, emergency disaster response, rapid housing and much more.

Corps Community Center -
The Salvation Army believes that worship, witness and service are inseparable. While church membership is not a prerequisite for receiving services, all are encouraged and welcome to attend our churches. Corps social service programs also vary according to the community they serve. Many feature food pantries, rent and utility assistance, as well as case management support for families in distress. In addition to providing for the physical needs of their clients, each Corps offers spiritual guidance through regular Sunday worship services, Bible school classes and programming to expand the spiritual growth of those who attend their services.

Residential and Institutional -
Our residential and institutional programs vary by community, however, the three primary programs in the Denver Metropolitan area are the Crossroads Shelter, Harbor Light Center and Lambuth Family Center. The Crossroads Shelter provides overnight shelter to approximately 400 homeless men each night, opening at 4:30pm daily. The Harbor Light Center is dedicated to helping those who are coping with homelessness and addictions. Upon entering the program, clients begin a 90-day educational track designed to address the issues that have brought them to The Salvation Army Harbor Light. On average, the program serves 250 men each year, one-third of which are veterans. The Lambuth Family Center is a 90-day family emergency shelter that serves approximately 80 families per year. The goal of the Lambuth Family Center is that all families served quickly secure stable and permanent housing in the Denver community through trauma informed supportive case management and enrichment services.
