NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- **Its approved exemption applications, all required attachments and any related correspondence with the IRS, and**
- **Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).**

In-person requests: *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an "unreasonable burden" on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

Written requests: *Written requests made by fax, mail, email, or overnight service, which include the requester's address, must be honored within 30 days of receipt.*

Website alternative: *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

Permissible charges: *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

Penalties: *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- *Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.*
- *Exemption Application - \$20 per day with no maximum.*
- *An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.*

Private foundation exempt: *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

Donor Information: *Please note that donor information is not open to public inspection and has been excluded from this copy.*



Residential - Tennyson Center for Children (TCC) offers four
residential cottages providing milieu therapy and individualized
treatment plans for male and female youth ages five to 18 years old
with a community-based and family-focused perspective. The programming
utilizes interventions focused on areas of therapy, education, health,
recreation, spiritual growth, social skill development, independent
living skills and healthy relationships. The strengths-based treatment
philosophy is integrated through all components of treatment. Focus
remains on shorter lengths of stay and bridging services of care to
lower levels so that families may be reunified or that youth may move
or return to a natural community setting. Experiential learning,
milieu activities and the volunteer program allow the needed community

Education Services and Day Treatment - TCC's on-grounds school
continues to be a leader amongst alternative school sites. Accredited
by the North Central Association of Colleges and Schools (NCA), the
educational programming utilizes special and regular education teachers
to provide individualized educational planning for each student.
Public school placement and stabilization is the goal for each student;
a comprehensive and individualized school transition plan is developed
and implemented in conjunction with the student's school district.
TCC offers a unique program, IDEAL, for Denver Public School District
students. This past year demonstrated a strong day treatment census
with referrals from an increasing array of county social services,
school districts, mental health agencies and insurance companies. TCC's

Community Based Family Services - TCC offers a number of
community-based programs to serve children and families. TCC's driving
philosophy is to provide prevention and intervention in the child's

protection and safety, reduce family conflict, stabilize basic needs,
or successfully reunify a child to the family after out-of-home
placement. Staff utilizes the family systems approach, focusing on the
family and their adaptation to the community. Treatment interventions
include therapy, case management, behavior management support, and
advocacy. Spanish-speaking and culturally-specific home based services
can be provided by our team of bilingual staff. An exciting

The national model of Positive Behavior Support (PBS) is a "broad range of systemic and individualized strategies for achieving important social and learning outcomes while preventing problem behavior" (PBS Manual, Sugai and Horner, September, 2005.) 2009 brought continued integration of this intervention between the school and residential programming, as well as utilization of the PBS data tracking system, SWIS, to access individual client trends to develop needed interventions and measure progress with behaviors. TCC staff also integrates portions of PBS with parents to utilize in their homes.

accomplishment in 2009 is the increased demand and demonstrated success of the program Home Environment Alternative to Residential Treatment (HEART). This program began in the fall of 2008 from a partnership with a local county department of human services in order to meet the increased needs of some families. HEART is an alternative to residential care for families whose children are struggling, emotionally or behaviorally, to adjust to their home life. Our in-home treatment is provided on days and times that are convenient and helpful to the family. Our goal is to support the family, teach new skills, and help each child have a permanent home. TCC was awarded a Statewide Strategic Use Fund through Temporary Assistance to Needy Families (TANF) to assist in expansion of this program.
