Page 1, Line 10: \$57,302 represents the purchase of one new suspension TrackChair (\$15,109) and the deposit of a second new Track

Chair (\$7555), the purchase of two manual Grit Chairs for paraplegics (\$9,443), two child safety seats for the TrackChairs (\$2,020),

two new batteries for the existing TrackChairs (\$948), and misc. associated maintenance and fitting out of the TrackChairs (\$1,079).

Also included are costs for Trail Maps, Banners and posters and awards to the volunteer trail guides for the TrackChair program (\$626),

And a refund to a single donor for unused restricted funds (\$7,500) at their request. We also purchased and installed a fishing shed

stocked with fishing carts, fishing poles, 50 fishing reels, pole holders, folding chairs, solar panels for the sheds to provide electricity at

a cost of \$4,116. A cash donation to the park of \$2,000 to help complete the new Visitor's Center, an Elk mount for above the fireplace in

the Visitor's Center (\$1,625), paint and misc. wall brackets and educational binders (\$2,160). Additionally, we donated \$1,411 for rock

climbing safety equipment, and \$1,710 was released from a restricted fund and into the Staunton Cabin Restoration project. All items .

were donated back to the park.

Page 2, Part III, Line 31a: \$3,120 represents:

As mentioned above, \$1,411 was the cost of purchasing rock climbing safety equipment for park visitors. The restricted balance of

\$1,710 for the purchase of Bike Bells was released by the donor to be added to the restricted fund for the Staunton Cabin restoration.
