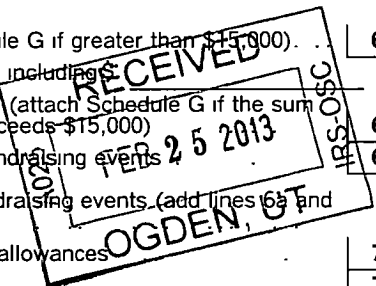



The primary purpose of Senior Resources of Broomfield, Inc. is to support the Meals on Wheels Program for the City/County of Broomfield. It also supports transportation costs of special trips for seniors. There is also a scholarship program for seniors who cannot afford to pay, or need some assistance for Meals on Wheels. About 250 seniors are assisted with supplemental funds for meals. There is also a scholarship program for seniors who are in need of some assistance with medical and dental bills. Ten or twelve seniors a year are assisted with medical or dental bills. A senior newsletter is prepared, printed and mailed six times a year.
