THE POLICY FURTHER STIPULATES THAT "A DISCLOSURE FORM WILL BE SIGNED BY DIRECTORS ANNUALLY AND REVIEWED BY THE EXECUTIVE COMMITTEE, HIGHLIGHTING ANY ACTUAL OR POTENTIAL CONFLICTS OF INTEREST".
