OUR QUALITY IMPROVEMENT INITIATIVES INCLUDE THE SCHOOL READINESS QUALITY IMPROVEMENT PROGRAM (SRQIP), INFANT TODDLER QUALITY AND AVAILABILITY PROGRAM (ITQA), AND SOCIAL EMOTIONAL EARLY DEVELOPMENT INITIATIVE (SEED). THESE PROGRAMS ENHANCE QUALITY IN EARLY CHILDHOOD EDUCATION IN ORDER TO IMPROVE THE SCHOOL READINESS OF DENVER CHILDREN BIRTH TO FIVE YEARS OLD. PROFESSIONAL DEVELOPMENT AND DENVER CHILDCARE RESOURCE & REFERRAL PROGRAMS EXPAND ACCESS TO HIGH QUALITY TRAINING PROGRAMS THAT PROVIDE PROFESSIONAL DEVELOPEMNT ON INDUSTRY BEST PRACTICE AND EVIDENCE-BASED CURRICULUM TO HELP EARLY CHILDHOOD PROFESSIONALS INCREASE THEIR KNOWLEDGE AND APPLY IT IN THE CLASSROOM. WE ARE WORKING TO INCREASE THE QUALITY, ACCESS, AND AVAILABILITY OF EARLY CHILDHOOD CARE AND EDUCATION (ECE) SERVICES.
