FIRST LEGO League (FLL; grades 4-8) whose focus is on solving real world problems through research, building, and competing with an autonomous LEGO based robot had 336 teams registered with 2,688 students participating. FIRST Robotics Competition (FRC; grades 9-12) is the flagship program challenging participating students to design and build a sophisticated robot in only six weeks from a standardized kit of parts competing in a different
