These animals represent over 130 different wildlife species. Treated animals are rehabilitated and re-released into the wild. Professional services valued at \$22,036 were donated to the Organization to assist in these program accomplishments.

Venues included summer camps, schools, scout troops, civic organizations, and community events.
