**Acquisition of private lands in designated and potential wilderness areas from willing sellers and transfer of those lands to public ownership so that all generations of Americans will enjoy an enduring source of wilderness. During the fiscal year ending June 30, 2017, The Wilderness Land Trust purchased five properties throughout Alaska, Colorado and Washington for a total of 217 acres, and transferred three properties in California totaling 244 acres. Currently, the Trust is active in Alaska, California, Colorado, Idaho, Nevada, New Mexico, Oregon and Washington on 18 projects totaling 7,600 acres. During its 25 year history, the Trust has permanently protected lands in 101 wilderness areas and made 15 wilderness areas complete.**

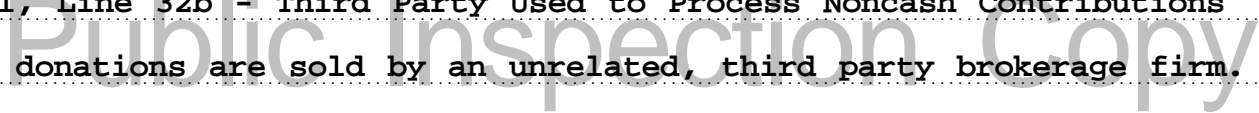

The Trust recorded a \$225,000 grant payable liability as of June 30, 2017, which is an estimate of the amount that will be repaid to the National Parks Trust (NPT) and Rocky Mountain Conservancy (RMC) when the Wild Basin/Hoffman property is sold. NPT, RMC and TWLT entered into a memorandum of understanding on October 25, 2016, the purpose of which was to finance the purchase and rehabilitation of the Wild Basin/Hoffman property. Each of the partner agencies contributed funds for the purchase and rehabilitation, and the grant payable liability is management's estimate of the amount that will be repaid to NPT and RMC when the property is sold, which is expected within the next 36 months.
