THE CASA PROGRAM HAD A RECORD BREAKING RECRUITMENT YEAR AND SWORE IN 92 NEW CASA VOLUNTEERS.OVER THE COURSE OF THE YEAR, 167 ACTIVE VOLUNTEERS PROVIDED ADVOCACY AND SUPPORT FOR 318 CHILDREN INVOLVED IN DEPENDENCY AND NEGLECT CASES. THESE CHILDREN SERVED ARE SOME OF THE COMMUNITY'S MOST VULNERABLE CITIZENS AND RANGE IN AGE FROM BIRTH TO 18 AND ARE VICTIMS OF PHYSICAL, SEXUAL AND/OR EMOTIONAL ABUSE OR HAVE BEEN NEGLECTED BY THEIR FAMILY TO A POINT OF SEVERE RISK. APPOINTED BY THE COURTS, THE CASA VOLUNTEERS GATHER INFORMATION FROM TEACHERS, DOCTORS, THERAPISTS, RELATIVES AND THE CHILD IN ORDER TO MAKE RECOMMENDATIONS TO THE COURT REGARDING SERVICES AND THE BEST PERMANENT HOME FOR THE CHILD.

THE SUPERVISED EXCHANGE AND VISITATION PROGRAM PROVIDED 2,295 SAFE VISITS AND EXCHANGES FOR 290 CHILDREN AND THEIR NON-CUSTODIAL PARENTS AND CAREGIVERS WITH 23 VOLUNTEERS/INTERNS SUPPORTING THIS CRITICAL WORK. THE VAST MAJORITY OF OUR CLIENTS ARE VICTIMS OF DOMESTIC VIOLENCE, CHILD ABUSE, AND NEGLECT, AND THIS PROGRAMMING IS TYPICALLY COURT ORDERED FOR THE VICTIM'S SAFETY. PROGRAMMING WAS EXPANDED IN 2019 TO INCLUDE TRAUMA-INFORMED PRACTICES, CASE MANAGEMENT AND AN EVIDENCE BASED PARENTING SKILLS PROGRAM: NURTURING PARENTING PROGRAM. THE NURTURING PARENTING PROGRAM IS A TRAUMA-INFORMED INITIATIVE DESIGNED TO BUILD APPROPRIATE AND RESPONSIVE PARENTING SKILLS AS AN ALTERNATIVE TO ABUSIVE AND NEGLECTING PARENTING AND CHILD-REARING PRACTICES.
