4a (Code:) (Expenses \$ 245,309. including grants of \$) (Revenue \$ 122,122.) Zach's Place. This program, the only one of its kind in the Pikes Peak Region, historically provided respite and child care programs along with school placements and community mentoring programs. In prior years, we provided academic programming for children from School District #11. In 2007 School District #11 created their own in-house programs for children with disabilities and our school placement program was no longer needed. In late 2007 and 2008, the agency initiated a monthly "gift of time" opportunity for parents who have never had respite care to try respite care on a weekend day for free. The result is that in 2008, we had 24 new children try the program.

We operate a before and after school program, evening, weekend, and 4b (Code:) (Expenses \$ 1,143,107. including grants of \$) (Revenue \$ 1,162,910.) Child Placement Agency. This program, started in 2002, is a foster care and adoption program for youth who have been abused and neglected. Over 50% of the youth in care in 2008 have a developmental disability. In December 2008, the program served 48 youth in homes along the Front Range, including such communities as Pueblo, Denver Metro, El Paso, and Teller Counties. Our foster care program also provides respite care for families referred through Pikes Peak Mental Health Center.

4c (Code:) (Expenses \$ 1,130,496. including grants of \$) (Revenue \$ 1,405,370.) I Can. Started in 2005, this program is a follow up on to Zach's Place. This program is a day habilitation program, serving adults 18 years and older. Several of the participants have emancipated into this program from Zach's Place. The program has more flexible scheduling to accommodate the needs of the consumer. The clientele have such diagnoses as Autism, Down's Syndrome, Angelman's Syndrome, and Seizure Disorders. The program involves accessing the community, and the majority of programming is conducted in the community. We are currently serving 40 adults.

In 2006, Special Kids/Special Families, Inc won a caregiver award from the Johnson & Johnson Foundation and the Rosalyn Carter Institute. Our
